11. CONTRIBUTIONS TO TEACHING PRACTICE:

a) Pedagogic Innovation and/or Development of Technology-Enhanced Learning:

Development of a new teaching method and new set of curriculums in a response to systemic challenges posed to teaching scientific courses in the context of humanities and to changes in the background preparation of students enrolled in our undergraduate programs. In addition, the development of a new teaching method addresses the need for tutorials (our undergraduate programs do not provide tutorial support for large classes above level 1) in scientific courses. The interactive learning method allows for including tutorial style of learning into a more classical lecture. The new method is strictly based on problem based learning insights and incorporates technology in the classroom to improve students involvement with the material and giving students more structured practice and feedback. The need for developing a new pedagogical approach was identified in a close collaboration with the McPherson institute and peers from McMaster and other universities worldwide. The innovation also addresses a number of issues raised in teaching evaluations and a survey conducted by the McPherson institute. The students enrolled in the relevant courses have contributed to the development of the method and the corresponding curriculums throughout by providing feedback and insights from their experience with interactive learning with other classes. The teaching evaluations, including a sharp increase in the number of students participating in the teaching evaluations, suggest that students have found the changes highly beneficial to their learning and have become invested in contributing to the development of the new teaching method and the corresponding curriculum.

Winter 2019: Developing an interactive learning class (LING 2SY3) in an interactive learning classroom (in consultation with the McPherson institute and peers from McMaster University and other institutions worldwide). The curriculum has been developed to address systemic challenges that resulted from the change in the background preparation of students and the dire need for tutorials.

Summer & Fall 2019: A continuation of developing of a novel approach to teaching scientifically based classes in the context of humanities. The course (LING 3II3 and preparation for LING 2SY3 for Winter 2020) has been systematically redesigned to include training in scientific reasoning and basic linguistics methods of investigation in parallel to teaching the content core of the classes.

Fall 2011: Developing a technological set up for delivering non-verbal content of linguistics classes to a student with disabilities (blindness). The project involved creating a technology for delivering the visual part of lectures to the student in a real time, a technological adaptation of existing toolkits to enhance knowledge transfer of methods designed primarily for visual perception (graphs). The tools were developed in

collaboration with SAS and became part of their archive of educational tools available to students with disabilities.

b) Leadership in Delivery of Educational Programs:

Spring & Summer 2019: development of a new course in linguistics awareness designed specifically for adults learners of Mohawk, an Indigenous polysynthetic languages; a pilot version of the course (a week long) taught at Onkwawenna Kentyohkwa, a Mohawk adult immersion school located in the Six Nations of the Grand River in the first week of September 2019; the project is part of an ongoing efforts for knowledge dissemination within Indigenous communities, and engaging university-based research in a community context; the course is to be offered again in summer 2020 (this time for Mohawk and Oneida speakers)

Organization of the Montreal-Ottawa-Toronto-Hamilton graduate workshop in syntax: this is a new workshop that intends to bring together graduate students from four leading Canadian programs in linguistics; the workshop has been designed to address pedagogical issues arising around graduate student research presentations and to create new networking and research collaborations among these four departments; the first instalment of the workshop took place in March 2013 at McMaster University, the second instantiation took place in March 2017.

Winter 2019: Developing an interactive learning class (LING 2SY3) in an interactive learning classroom (in consultation with the McPherson institute and peers from McMaster University and other institutions worldwide). The curriculum has been developed to address systemic challenges that resulted from the change in the background preparation of students and the dire need for tutorials. The curriculum development included a development of an entirely new set of lectures, class presentations, in-class group exercises, i-clicker exercises, homework assignments and three in-class exams.

Summer & Fall 2019: A continuation of developing of a novel approach to teaching scientifically based classes in the context of humanities. The course (LING 3I13 and preparation for LING 2SY3 for Winter 2020) has been systematically redesigned to include training in scientific reasoning and basic linguistics methods of investigation in parallel to teaching the content core of the classes. The course change included a thorough redesign of an existing class, redoing all lecture slides, assignments and the corresponding examination. The teaching evaluations, including a sharp increase in the number of students participating in the teaching evaluations, suggest that students have found the changes highly beneficial to their learning and have become invested in

contributing to the development of the new teaching method and the corresponding curriculum.

Developing a peer-review assessment method as part of LINGUIST 4LC3 with an emphasis on developing course objectives, writing skills, identification of transferable skill and their application to new material.
